## CAMPGROUND RULES

- All customers are responsible for maintaining and keeping their assigned camping areas cleaned and at all times.
- All customers are responsible for proper waste, water and electrical connections at all times.
- Registration permit must be displayed in a visible location, facing the street, on the RV, trailer or tent.
- All vehicles, RV's and trailers must be parked on campsite or driveway. Driving or parking off road is not permitted.
- All vehicles, trailers, equipment, etc., will be secured when unattended. The USAF and 910 FSS are not responsible for lost, stolen or damaged property.
- All vehicles (to include any motorized vehicle), utility trailers, boats, boat trailers and jet skis must have current registrations and insurance, if required.
- 910 FSS and the Army Air Force Exchange Services are the only agencies authorized to sell alcoholic beverages for public consumption on Youngstown Air Reserve Station. The consumption of alcoholic beverages in the recreation areas by anyone under the age of 21 years is prohibited.
- Campfires are only authorized in the FAMCAMP barbeque grills.
  - \*Open flames must be monitored at all times and completely extinguished before leaving. A bucket of water or sand must be in close proximity to aid in dousing the fire.
  - \*If winds are greater than 10 mph or gusting to 15 mph, all open fires must be extinguished immediately.
- Explosive materials, firearms, ammunition, weapons of any kind are prohibited (hand guns, air pistols, rifles, shotguns, automatic or semi-automatic weapons). Use of fireworks or other explosives is also prohibited. Customers can contact 910 Security Forces Squadron Base Defense Operations Center at 330-609-1277 for guidance and control of such firearms.

## CAMPGROUND RULES CON'T

- Hunting is prohibited.
- All garbage and litter must either be deposited in containers provided, or taken with when departing. Dumping of petroleum products, solvents, pesticides, chemicals, etc., are prohibited. "Gray Water" can be disposed of at the Dump Station next to Building 554.
- Individual clothes drying lines are prohibited.
- Tobacco use in designated tobacco areas (DTA) only.
- Quiet hours in the FAMCAMP are 2200—0800 daily.
- RVs are prohibited from being washed on site. Local water restrictions will be adhered to at all times.
- Children 16 years of age or younger must be accompanied by an adult sponsor (18 years or older) at all times during their stay .
- Guests of customers cannot stay overnight in the campground unless they are staying in the same RV as the eligible customer.
- Boats, utility and car trailers are prohibited on the same campsite as the RV. All small utility trailers, boats, large trailers, and other vehicles must be parked in the over-flow parking area.

## PET POLICY

Pets and certified service dogs are allowed as follows:

- No more than two (2) four-legged pets are allowed by a FAMCAMP primitive camping customer at any given time while registered for the campground.
- It is prohibited to have pets in cages / kennels or tied outside the RV at any time.
- The guest must be outside the RV with their pets. The pets must be on a leash and under positive control at all times.
- Pets must be inside the RV or tent when guests are away from the campground but must not be left unattended for a period exceeding 2 hours.
- Pets must never be left unattended in closed vehicles during extreme heat conditions.
- Guests are responsible for immediately collecting, bagging and then disposing of pet waste in the designated dumpsters.
- Failure to follow this OI will result in the termination of the guest's registration in the campground. The guest will be required to depart immediately.
